

Terms And Conditions For Personal Charge Card

DINERS CLUB (SA) PROPRIETARY LIMITED (DINERS CLUB/WE/US/OUR) TERMS AND CONDITIONS (TERMS) FOR THE BLACK FRIDAY CASHBACK PROMOTIONAL OFFER

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. INTRODUCTION

- 1.1. Get up to R1000.00 (one thousand Rand) cashback when you spend a minimum of R2000 (Two thousand Rand) online or in-store using your Diners Club consumer credit card (**Card**) on Black Friday 2021 (**Offer**) - this Offer is limited to 20 (twenty) customers who use their Card to pay for their purchases online and in-store on Black Friday and will be done by means of a lucky draw.
- 1.2. The Offer starts at 00:00 on Friday, 26 November 2021 and ends at 23:59 on Friday, 26 November 2021 (**Offer Period**).

2. WHO QUALIFIES FOR THE OFFER

To qualify for the Offer, you must meet the following requirements:

- 2.1. be 18 years or older;
- 2.2. permanently reside in the Republic of South Africa;
- 2.3. be the holder of a valid and active Card, whose Card account is in good standing.
- 2.4. excludes Diners Club and Standard Bank staff.

3. HOW TO ACCEPT THE OFFER

- 3.1. 20 (twenty) customers to spend a minimum of R2000.00 (two thousand Rand) online or in-store using your Card during the Offer Period, will be eligible to receive up to R1000.00 (one thousand Rand) cashback by means of a lucky draw.
- 3.2. If you comply with the requirements set out in clause 2 above and this clause 3, you automatically qualify for the Offer.
- 3.3. You may only take up the Offer once during the Offer Period.
