AIRPORT LOUNGE

For every R8 800 you spend in a quarter, you will qualify for one lounge visit. The more you spend, the more complimentary visits you qualify for. (A quarter is defined as the calendar months from January to March, from April to June, from July to September and from October to December.)

LOUNGE ACCESS FOR CHILDREN UNDER THE AGE OF 16

Members are welcome to bring three children under the age of 16 into the domestic lounges. No add-on cards are required but the visits will be deducted from the number of visits earned according to the qualifying criteria. Any visits earned and not used in the same quarter, are carried over to the next quarter but expire if not used by the end of 2025. If the spend requirements are not met, the following guest fees will apply:
